

COVID WAIVER

ASSUMPTION OF RISK AND WAIVER OF LIABILITY

PLEASE READ CAREFULLY. THIS ASSUMPTION OF RISK AND WAIVER OF LIABILITY HAS LEGAL CONSEQUENCES AND WILL AFFECT YOUR LEGAL RIGHTS AND ABILITY TO BRING FUTURE LEGAL ACTIONS.

In CONSIDERATION of being permitted to participate in the Orlegi Chula Vista Cup 8, conducted on August 18-20th, 2022 (the "Event"), I, _____, hereby acknowledge and agree as follows:

By entering my name and checking the box below, to this Assumption of Risk and Waiver of Liability (this "Waiver"), I hereby release and discharge Orlegi Group or any of its affiliates ("Orlegi"), and each of its respective officers, directors, representatives, employees, subcontractors, sponsors, affiliates and successors and assigns (collectively, the "Releasees"), from all claims, damages, costs, liabilities and expenses (including without limitation reasonable legal fees and expenses) which I may have, whether known or unknown, asserted or not asserted, arising out of my participation in the Event.

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) from the activities involved in this program are significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation;

ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATED TO CORONAVIRUS/COVID-19

I, _____, acknowledge the following:

There is an ongoing pandemic of COVID-19, a contagious virus which may cause severe illness, other adverse medical reactions, quarantine requirements, transmission to friends and/or family, and/or death in addition to other adverse results, the scope of which may not be fully understood given that COVID-19 is a novel virus and has not yet been fully evaluated by the medical community ("Virus Risks"). COVID-19 is believed to spread mainly from person-to-person contact, aerosol droplets, and also through surfaces, and it may be spread by individuals who are pre-symptomatic or asymptomatic.

My participation in this Event will substantially increase my risk of exposure to COVID-19, given that, by their nature, participation in the Event involves person-to-person contact. I agree to assume full responsibility for any resulting Virus Risks, whether they be known or unknown.

Orlegi Group and their affiliates have established certain requirements and protocols ("Protocols") in consultation with medical consultants designed to reduce the Virus Risks; however, significant Virus Risk remains despite the Protocols. The Protocols include the requirement that all players, including academy players and trialists, submit to regular COVID-19 testing and agree to share the results of such testing with certain persons in order to prevent the spread of the virus. I agree to strictly comply with the Protocols, including by submitting to testing and agreeing to share any results of the testing as set forth therein.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Orlegi Group, and each of its respective directors, officers, officials, agents and/or employees, associated personnel, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), from any and all claims, demands, losses, and liability arising out of or related to any ILLNESS, INJURY, DISABILITY OR DEATH that I or a third party may suffer as a result of the Virus Risks or the Soccer Activities, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
